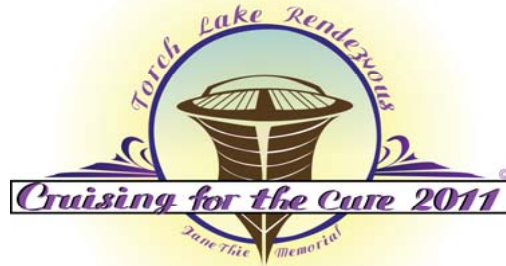

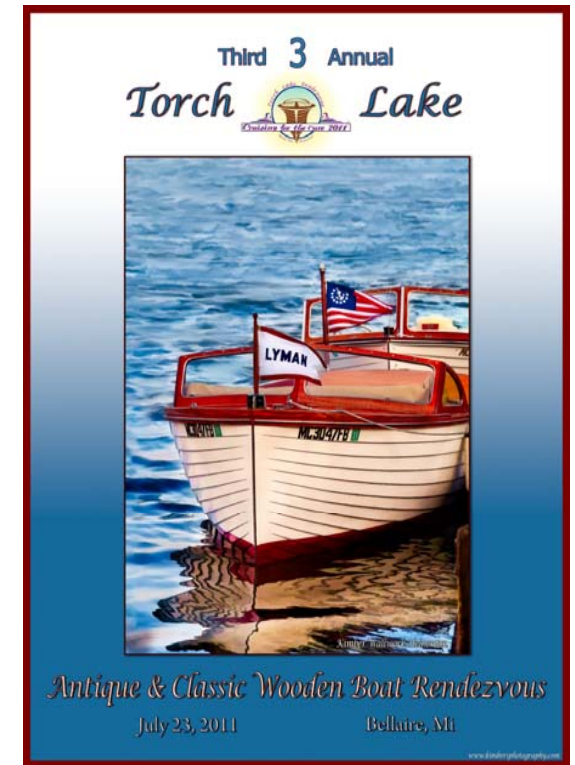

Nestled in the quiet Harbors of Clam River, adjacent to beautiful Torch Lake near Bellaire, Michigan, the Torch Lake Rendezvous—Cruising for the Cure 2011 is an in-water antique and classic wooden boat exhibition, parade of boats and photo shoot dedicated to the memory of Jane H. Thie. Net proceeds from the event go to the Jane H. Thie Memorial Fund, Inc. and benefit the Barbara Ann Karmanos Cancer Institute, Michigan's only hospital focused solely on cancer, in its efforts in advancing ongoing research in the early detection and eradication of pancreatic cancer.

Antique and classic wooden boats built prior to and including 1969, as well as boats of wooden construction built post 1969, that receive an invitation or are home to Antrim County's Chain-O-Lakes region are eligible for entry.

Most of these vintage entries are actively used during the summer months and arrive by water from Lake Bellaire, Clam Lake, Elk Lake, Lake Skegemog, Torch Lake and other tributaries of Antrim County's picturesque Chain-O-Lakes.

Mooring spaces are limited so we encourage you to **register early**. For your registration fee, you will receive a gift bag, launch and retrieval assistance and coffee and donuts at check-in.
